- 5. Electronic bids must be submitted to through PPMO website *www.bolpatra.gov.np/egp* on or before 12:00pm on 2077/01/12. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00pm on 2077/01/12 at the office of *Aalital Rural Municipality*. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of *above mentioned amount* which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days *beyond bid opening date*)
