

Invitation for Bids for the **Construction of 10 Bed Aalital Health Post Building, Aalital Rural Municipality, Ward no. 8**

1. The Government of Nepal [GoN] *has allocated funds* towards the cost of **Construction of 10 Bed Aalital Health Post Building** and intends to apply part of the funds to cover eligible payments under the Contract for **ATLRM/DDDL/NCBWORKS/01/2077/078**. Bidding is open to all eligible as per Section V of bidding document.
2. **Aalital Rural Municipality Office** invites electronic bids from eligible bidders for the **Construction of 10 Bed Aalital Health Post Building, Septic Tank, Soak Pit, Water tank, Land development work, Compound Wall, Gate, Water Supply works, Sanitation Works and Electrical Works** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. Ten crores.**
  - Minimum Work experience of similar size and nature: **At least one Contract within the last ten (10) years, each with a value of at least NRs. Nine crores that have been successfully or are substantially completed and that are similar to the proposed works.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Bidders should deposit the cost of bidding document (**NRs. 10,000**) in the Aalital Gaunpalika Aantarik Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at **Aalital Rural Municipality Office at 4pm on 2077/10/19**.
7. Electronic bids must be submitted to the office **Aalital Rural Municipality, Aalital-5 Bhimdattapur, Dadeldhura** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00pm on 2077/11/06**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 2077/11/06** at the office of **Aalital Rural Municipality, Aalital-5 Bhimdattapur, Dadeldhura**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 35 Lakhs** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
11. In other things not mentioned in this notice, Public procurement Act 2063 and Public Procurement Regulation 2064 or current governmental laws will be applicable.
